3. Pursuant to Section 608.441(b), Florida Statutes, the Company is dissolved as set forth in its Operating Agreement upon the determination of its Member.


4. All debts, obligations, and liabilities of the Company have been paid or discharged.

5. All remaining property and assets have been distributed to the Member in accordance with its respective right and interest.


6. There are no lawsuits pending against the Company in any court.
