NAME

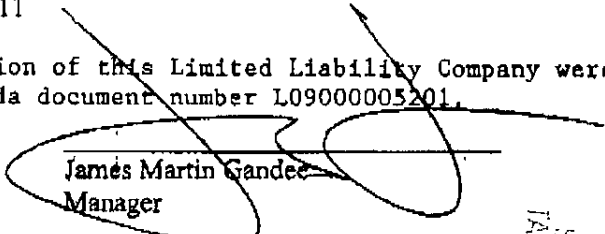
The name of the limited liability company shall be: LearnSmart, LLC.
