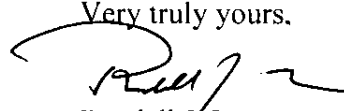

**ARTICLES OF ORGANIZATION
OF
LOKAET-NOW, LLC**

The undersigned hereby executes and acknowledges the following Articles of Organization for the purpose of forming a limited liability company in the State of Florida under the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes.

1. Name of LLC:

The name of the limited liability company is Lokaet-Now, LLC.

2. Address:

The street address of Lokaet-Now, LLC is 1262 Travertine Terrace, Sanford, Florida 32771.

3. Registered Agents:

The registered agent of Lokaet-Now, LLC for the purpose of service of process is Philip A. Smith, 1262 Travertine Terrace, Sanford, Florida 32771.

5. Name and Address of Each Organizer:

The name and business address of each organizer is:

6. Perpetual Duration:

The period of duration of Lokaet-Now, LLC is perpetual.

7. Capital Contributions:

The members of Lokaet-Now, LLC shall contribute to the capital of the company the cash or property set forth in the affidavit of membership of contributions. Each member shall execute an affidavit of membership contributions at such time as the member contributes capital to the company. Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

8. Management:

The company shall be managed by a manager in accordance with the operating agreement and regulations adopted by the members for the management of the

business and affairs of the company. The operating agreement and regulations may contain any provision for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. The manager shall have such authority and duties as set forth in the regulations and as provided in Chapter § 608.422, Florida Statutes. All managers shall be subject to the general standards of conduct and care set forth in Chapter § 608.4225, Florida Statutes. Such duties shall include, without limitation, the duty of loyalty to the company and the duty of care in refraining from engaging in grossly negligent or reckless conduct, intentional misconduct or a knowing violation of law. In performing his or her duties, any manager may rely upon information, reports, advice, opinions and statements, including financial statements, provided by legal counsel, public accountants or other persons the manager reasonably believes are within the provider's expert or professional competence. The company shall indemnify every manager, his or her heirs, executors, administrators, and assigns against any expense actually and reasonably incurred by the managers, as well as against any claim, cause of action or judgment, including reasonable attorney's fees, in connection with any judicial or administrative action to which the manager may be a party by reason of having been a manager of this company. The name and address of the initial manager is Philip A Smith, 1262 Travertine Terrace, Sanford, Florida 32771.

9. Admission of New Members:

No person may be admitted as a member unless a majority-in-interest of the members consent in writing to the admission of the additional member pursuant to Fla. Stat. § 608.4232.

10. Voting:

Each percentage of membership interest has one vote on each matter on which the membership interest is entitled to vote. With respect to any matter, other than the additional contribution of capital or as otherwise set forth in the operating agreement and regulations of the company, the act of the members on that matter shall be the affirmative vote of the holders of a majority of the membership interest entitled to vote on that matter. Members shall have the right to vote on the dissolution of the company as provided in Fla. Stat. § 608.411 and on a merger of the company as provided in Fla. Stat. § 608.4381. The members may take such action without a meeting without prior notice and without a vote if a consent or consents in writing setting forth the action so taken, are signed by the members having not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting.

11. Continuation of Business:

The company shall be dissolved in the event of the death, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority of the remaining members.

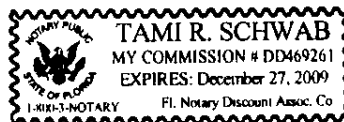
