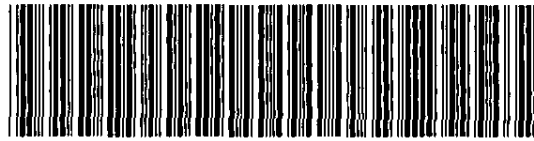

**ARTICLES OF ORGANIZATION
OF

The undersigned, R. TOM CHAPMAN, as the subscriber to these Articles of Organization, hereby presents these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be SOUTHERN OAKS GROVE, LLC

**ARTICLE II.
TERM OF EXISTENCE**

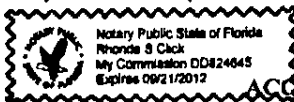
