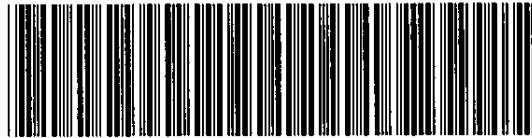

**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
OF
Lowe Harbour Key Investments, LLC
(A Florida Limited Liability Company)**

FIRST: The Articles of Organization for this Limited Liability Company were filed on January 16th, 2009 and assigned Florida document number L09000005476.

SECOND: The following amendments to the Articles of Organization were adopted by this limited liability company:
