**ARTICLES OF ORGANIZATION****OF****BAGA FAMILY, LLC**

The undersigned person, acting as the organizer of BAGA FAMILY, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**

The name of this limited liability company is:

ARTICLE X - TERMINATION OF MEMBERSHIP INTEREST




