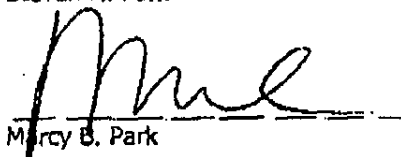
ARTICLE V — EFFECTIVE DATE
