MEMBERS' RIGHTS TO CONTINUE BUSINESS**

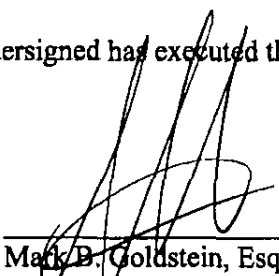
The remaining members of the limited liability company may, pursuant to the vote of members possessing a majority of membership interests in the limited liability company, continue
