ARTICLES OF ORGANIZATION

OF

M.T. WALL, L.L.C.

The undersigned persons, acting as the organizers of **M.T. WALL, L.L.C.**, (The "Company") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopt the following Articles of Organization:

ARTICLE I. NAME AND ADDRESS

The name and address of the Company is: **M.T. WALL, L.L.C.**, located at 4350 Green Key Road, New Port Richey, Florida 34652.

ARTICLE II. COMMENCEMENT AND DURATION OF EXISTENCE
