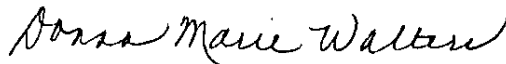

Name**

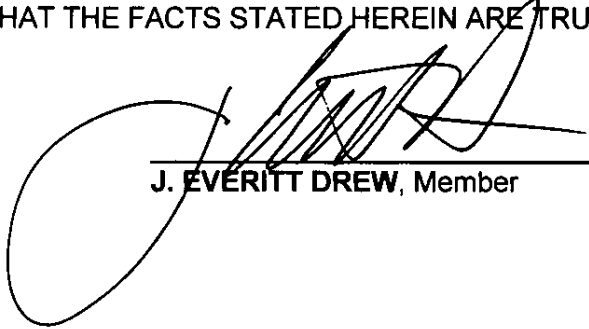
*The name of the Limited Liability Company is **JEDJLD, LLC**.*
