OS JAN 22 PA 11. 35 The undersigned, for the purpose of forming a limited liability company under the Florida. Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be STFEN3 LLC ("Company").

ARTICLE II - ADDRESS
