**ARTICLES OF ORGANIZATION  
OF  
BUSINESS SUPPLIES INTERNATIONAL, LLC.  
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as organizer and as a Member or authorized representative of a Member of BUSINESS SUPPLIES INTERNATIONAL, LLC under Section 608.407 of the Florida Limited Liability Company Act, hereby adopts the following articles of Organizations:

**ARTICLE 1.**

**NAME**

### **RELATIONSHIP OF ARTICLES OF ORGANIZATION TO OPERATING AGREEMENT**

If any provision of these articles of Organization differs or otherwise conflicts with any provision of the Operating Agreement, then, to the extent allowed by applicable law, the Operating agreement shall govern.

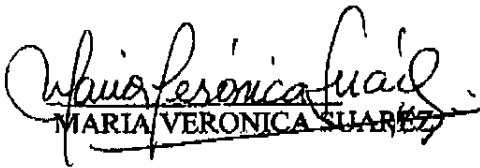
