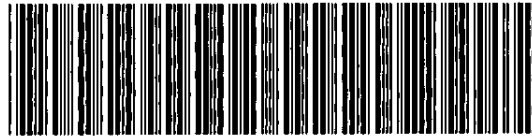

##### Additional Provisions


The power to adopt, alter, amend, or repeal the regulations of the Company, and the management of said Company, shall be as set forth in the Operating Agreement of said Company.


