ARTICLES OF ORGANIZATION OF RE-DRESS HER DAY, LLC

- 1. NAME. The name of this limited liability company is Re-Dress Her Day, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
