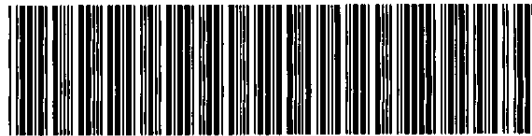

Registered Agent and Office

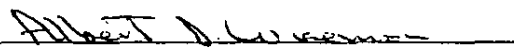
