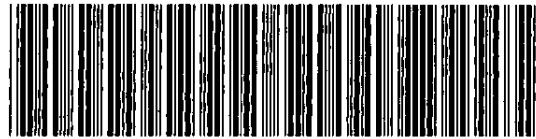

**ARTICLES OF ORGANIZATION OF  
D'ADDARIO INTERNATIONAL, LLC**

**Article I**

The name of the limited liability company ("Company") is D'ADDARIO INTERNATIONAL, LLC.

**Article II**

The mailing address of the Company is 32 Bonita Road, DeBary, Florida 32713 and street address of the Company's principal office is 32 Bonita Road, DeBary, Florida 32713. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

**Article III**

The period of duration for the Company is perpetual.

**Article IV**

The name of the Company's initial registered agent in Florida is Paul M. D'Addario. The address of the Company's registered office in Florida is 32 Bonita Road, DeBary, Florida 32713.

**Article V**


**Article VII**


