



## ARTICLES OF ORGANIZATION OF



#### MAROTTA PROPERTIES, LLC

The undersigned persons hereby adopt these Articles of Organization in order to FURIDA form a limited liability company under Chapter 608 of the Florida Statutes.

#### **ARTICLE I – NAME**

The name of this limited liability company shall be MAROTTA PROPERTIES, LLC (the "Company").

#### **ARTICLE II – DURATION**

The Company shall commence upon the execution of these Articles and shall exist perpetually.

#### ARTICLE III - PURPOSE

The purpose of the Company is to engage in any lawful business activity that is not prohibited with respect to a limited liability company organized according to the laws of the State of Florida.

#### ARTICLE IV - ADDRESS

The remaining Member(s) of the Company may continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company upon unanimous agreement and as provided in the regulations of the Company.

#### **ARTICLE VIII – MANAGEMENT**

The Company shall be managed by three (3) or more managers. The number of the initial managers, who shall serve as managers until the first annual meeting of the Members of the Company or until their successors are duly elected, shall be three (3).
