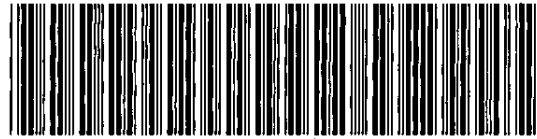

**ARTICLE III – PRINCIPAL OFFICE**

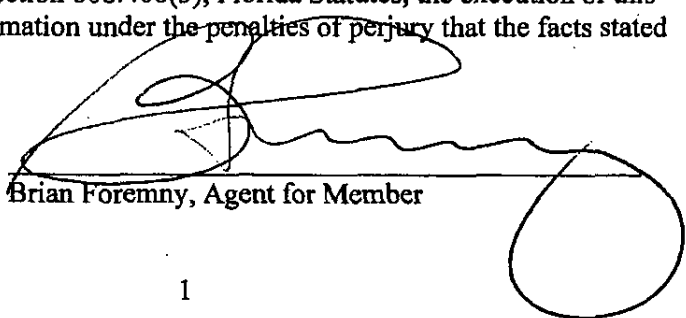

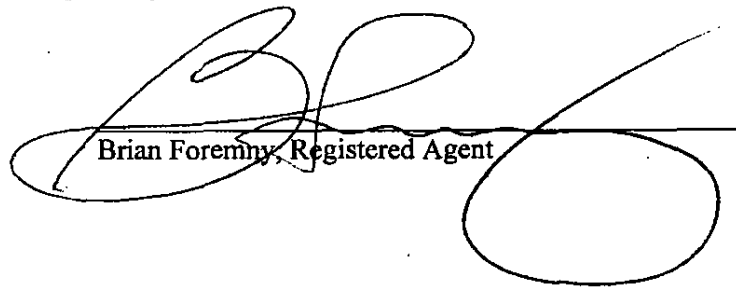
