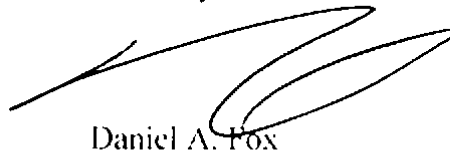
I represent RICHARD C. FOX PLBG, L.L.C. (hereafter, "Client"). My Client seeks to amend its name on file with the Department of State to RICHARD C. FOX PLUMBING, LLC. It is my understanding that my Client initially registered its name using the "PLBG" abbreviation for "Plumbing" due to another entity (now dissolved) having been previously registered using a name that was otherwise indistinguishable but for the designation as an LLC versus a corporation. My name is Denise M. Fox. I was a director and the president of the now dissolved Florida corporation, RICHARD C. FOX PLUMBING, INC. (hereafter, "Corporation"), which had been assigned Florida document number P05000011242 on the files of the Department of State. Corporation was administratively dissolved on or about September 14, 2007 and has conducted no business activities since the date of dissolution other than as necessary to wind up its affairs. I am the only remaining director and officer of the Corporation, and I am otherwise authorized to give this written consent on behalf of Corporation.

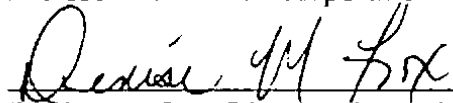
Corporation and the applicant seeking to change its name, RICHARD C. FOX PLBG. L.L.C., a Florida limited liability company (document number L09000008722), are separate and distinct entities, each having their own unique Federal Employer Identification Number. RICHARD C. FOX PLBG. L.L.C. was independently organized on or about January 27, 2009 and such event was not the result of conversion from the Corporation.

RICHARD C. FOX PLBG. L.L.C. has requested that Corporation provide written consent to the Department of State for RICHARD C. FOX PLBG. L.L.C. to change its name to RICHARD C. FOX PLUMBING, LLC, a name that is not identical to the Corporation but is not otherwise distinguishable from that of the Corporation other than the designation of the type of business entity.

Pursuant to section 605.0112(b), Corporation hereby provides written notice to the Department of State of Corporation's consent for RICHARD C. FOX PLBG. L.L.C. to amend its name to RICHARD C.
