ARTICLES OF ORGANIZATION
OF
MAC'S OUTDOOR SERVICES, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is MAC'S OUTDOOR SERVICES, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 1615 Americus Ave., Pensacola, FL 32507, and its mailing address is 1615 Americus Ave., Pensacola, FL 32507, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

ARTICLE III
MANAGEMENT

The business of the Company shall be managed by one or more managers chosen by the Company's Member or Members.

ARTICLE IV
OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Member or Members unless vested in the manager of the Company by any amendments of the Articles of Organization. The Operating Agreement adopted by the Member or Members may be repealed or altered, a new Operating Agreement may be adopted by the Member or Members, and the Member or Members may prescribe in any Operating Agreement made by them that such Operating Agreement may not be altered, amended or repealed by the manager.

ARTICLE V
AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and sworn to by the Member or all Members

of the Company. In the event a new Member is added by such amendment, it shall also be signed by the Member to be added.
