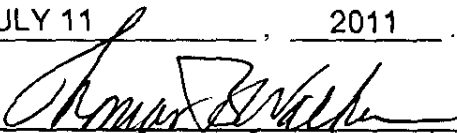

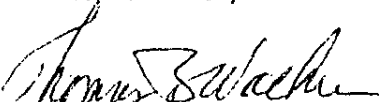

**ARTICLE VII:** In accord with the ownership and capital financial structure permitted for a Florida Limited Liability Company by Florida Statutes, and in order to permit future growth and financial flexibility, Barclay Breland Family Office, LLC is authorized to provide founders and owners differing ownership rights and interests in the company. The Company may issue as many series of ownership interests as may be permitted by Florida Statute when authorized by the Barclay Breland Family Office, LLC Limited Liability Operating Agreement dated January 23, 2009, including subsequent amendments. However, no more than three initial series are authorized by this Article, as follows: one series to founders, one series to capital investors, and one series reserved for the company's future purposes. The statement of the terms and conditions of the individual series of ownership rights and interests are to be defined by the Operating Agreement.
