ARTICLES OF ORGANIZATION OF IT DYNAMIC, LLC

The undersigned Members, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be:

IT DYNAMIC, LLC (hereinafter "the Company").

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE

The purpose of the Company is to engage in every phase of any and all activities or business purposes permitted by the laws of the United States and the State of Florida or any other state, territory, district, or possession of the United States and all such activities or business as may be permitted in any foreign country.

The period of duration of the Company shall be perpetual, from January 23, 2009, unless the Company is dissolved earlier upon a determination by Members owning more than 50% of the Company, that the Company should be dissolved, or at such earlier time as provided by applicable law.

ARTICLE VI -MANAGEMENT AND CONTROL OF THE COMPANY

The company shall be managed the Members ("Members") in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization.

ARTICLE VII -CAPITAL AND CAPITAL ACCOUNTS

Additional capital may be contributed to the Company, but only on the written consent of all of the Members. No interest may be paid on Capital Contributions. An individual capital account ("Capital Account") must be established and maintained on behalf of each Member, including any additional or substituted Member who shall hereafter receive an interest in the Company. The Capital Accounts of each Member consists of the amount of cash the Member has contributed to the Company, and/or the agreed fair market value of any property or in-kind contribution the Member has contributed to the Company, less appropriate liabilities and adjustments as provided in the Operating Agreement.

ARTICLE VIII -INITIAL MEMBERS; PERCENTAGE INTEREST UNITS

ARTICLE IX -ADMISSION OF NEW MEMBERS

Except as expressly provided otherwise herein or otherwise agreed, no additional members shall be admitted to the Company except by written consent of all of the Members.

ARTICLE X - TRANSFERABILITY OF MEMBERS' INTEREST


Any Member shall have the right to assign that Member's interest in the Company upon such terms as such Member agrees, except that the assignee of such interest shall only be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss, deduction, credit or similar item to which the assignor was entitled, to the extent assigned. However, such assignee may not become a Member, unless approved pursuant to Article IX above, and therefore, such assignee may not exercise voting rights, or other rights reserved to the Members, unless admitted to the Company pursuant to Article IX. No Member may transfer all or any part of such Member's interest as a member of the Company except as permitted in these Articles, or in the corresponding Operating Agreement. Any purported transfer of an interest in violation of the terms of this agreement will be null and void and of no effect. For purposes of this section a "transfer" includes a sale, exchange, pledge, or other disposition, voluntarily or by operation of law.

ARTICLE XII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The business of the Company shall continue, notwithstanding the death, bankruptcy, or dissolution of a Member or a Manager, or on the occurrence of any other event that terminates the continued membership of a Member in the Company (including insanity, retirement, resignation, and expulsion of a Member or manager), as provided in the Operating Agreement of the Company.
