**ARTICLE I — Name:**

**ARTICLE III — Effective Date and Duration:**

The effective date of this Limited Liability Company shall be January 30<sup>th</sup>, 2009 and the period of duration for the Limited Liability Company shall be perpetual from the date of the issuance of a Certificate of Organization by the State of Florida.

**ARTICLE IV — Members and Management:**

This Limited Liability Company shall have at least one member and may admit additional members in accordance with these Articles and any duly executed Operating Agreement agreed upon by the Member(s). This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The Company may, upon the unanimous consent of the members, also designate persons as directors under the Operating Agreement who shall act in a manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually *unless otherwise specified in the Operating Agreement*, in person or by proxy, shall designate the manager(s), who may also be one or more of the members, and the positions that the manager(s) will hold. The initial manager(s), who shall serve until the first annual meeting of the members or until their successors are elected and qualify, and their designations shall be as follows:


## ARTICLE IX — Indemnification
