**ARTICLE I
NAME**

The name of the Limited Liability Company (the "Company") is OCEAN AIR JET CHARTER, LLC.

**ARTICLE II
ADDRESS**

The Company is to be managed by one or more members and is, therefore, a member-managed company.


**ARTICLE V


CERTIFICATE OF ACCEPTANCE BY REGISTERED AGENT
