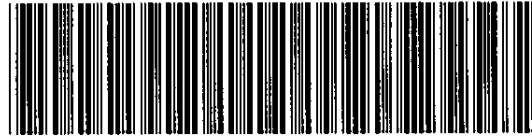

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

The mailing address and street address of the principal office of the Company is 4407 Vineland Road, Suite D-4, Orlando, Florida 32881.


**ARTICLE III
