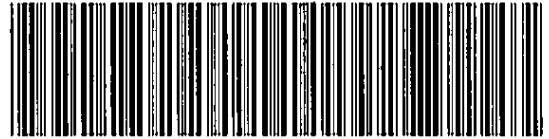


THIRD: The date of the above amendments adoption is July 29, 2019.
