REGISTERED AGENT**

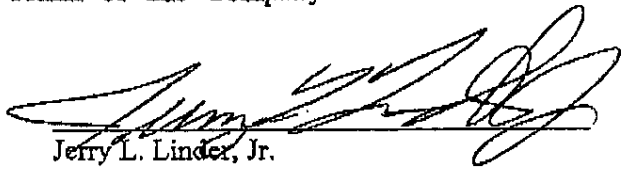

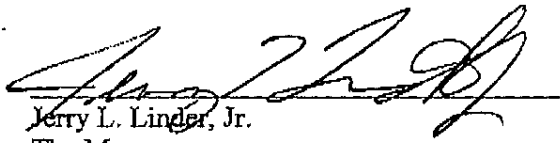

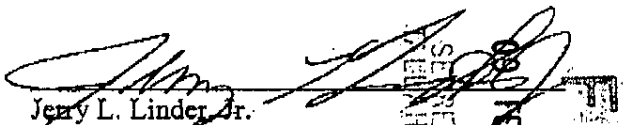
