1. The Name of the limited liability company is: Property Solutions Alliance, LLC. ("Company").

2. The date of filing of the Articles of Organization of the Company was February 3, 2009, and assigned document number: L09000011082

4. Except as amended hereby, the Articles of Organization shall remain in full force and effect.


