ARTICLES OF ORGANIZATION*of***JIMMY SMITH ATHLETICS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I**NAME**

The name of the limited liability company shall be Jimmy Smith Athletics, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 2804 St. Johns Bluff Road, Suite 105, Jacksonville, Florida 32246.

ARTICLE II**PURPOSES AND POWERS**

ARTICLE V**TERMINATION OF EXISTENCE**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

ARTICLE VI**MANAGER**




