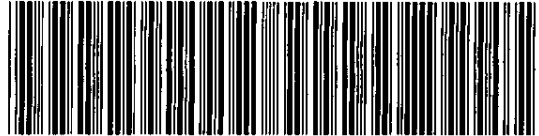

**ARTICLES OF ORGANIZATION OF
THE OAKS BY AMICORP, LLC**

Article I

The name of the limited liability company ("Company") is THE OAKS BY AMICORP, LLC.

Article II
