

ARTICLES OF ORGANIZATION  
OF  
FOR-CLOSE-UPS

The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I—NAME

The name of the limited liability company shall be FOR-CLOSE-UPS, LLC. ("company")

ARTICLE II—ADDRESS

The mailing address is 129 Indian Creek Road, Oak Hill, FL 32759 and street address of the principal office of the company shall be 129 Indian Creek Road, Oak Hill, FL 32759.

ARTICLE III—DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV—REGISTERED OFFICE AND AGENT
