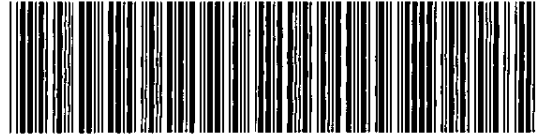

ARTICLES OF ORGANIZATION
OF

The undersigned, authorized representative of the members, hereinafter named, certifies that the members have associated themselves together for the purpose of becoming a limited liability company pursuant to the laws of the State of Florida (Ch. 608, Florida Statutes), which provide for the formation, rights, privileges and immunities of limited liability companies for profit. The members further declare that the following Articles shall be the Charter and authority for the conduct of business of this limited liability company.

ARTICLE I

NAME

The name of this limited liability company is, and shall be, CANNON GROUP FINANCIAL SERVICES, L.L.C., and its principal place of business shall be in Volusia County, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

DURATION

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE V

RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members by consent of the Managing Member. Capital contributions required of new members shall be determined as of the time of their admission to this limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except in accordance with the Operating Agreement and new members will be admitted to membership only with the consent of the Managing Member.

Upon the death, retirement, resignation, bankruptcy or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to

continue the business upon consent by a majority of the remaining members.

ARTICLE VI

PURPOSE

The purposes for which this limited liability company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. This limited liability company shall have all of the powers vested by law in limited liability companies organized and existing pursuant to such laws.

ARTICLE VII

ARTICLE IX

MANAGEMENT

This limited liability company shall be managed and its powers exercised by a Managing Member to be elected from time to time by the members. DANIEL P.
