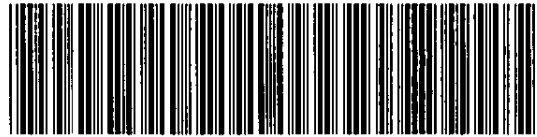

Article IV – Management


