**AMENDED AND RESTATED ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
CHANNEL TOWN, LLC**

Pursuant to the Florida Limited Liability Company Act, **CHANNEL TOWN, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the Company is: **CHANNEL TOWN, LLC**

SECOND: The Articles of Organization of the Company were filed on February 6, 2009 and assigned document number L09000012937.

THIRD: Article III of the Articles of Organization of the Company, as amended, is hereby amended and restated in its entirety as follows:


