Management of the Limited Liability Company is reserved to its sole member. The name of the sole Member is Sean Farrell.

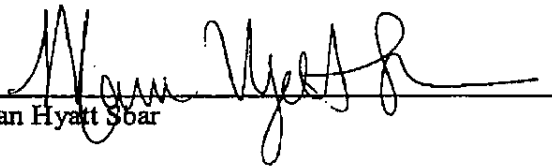

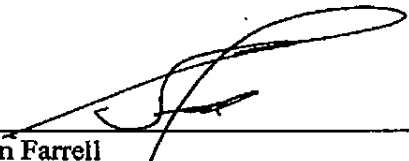
