**ARTICLES OF DISSOLUTION**

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

**FIRST:** The name and address of this Company is **AMERICAN COIN GROUP, LLC**, 405 18th Avenue, Indian Rocks Beach, Florida 33785.

**SECOND:** The date of the adoption of these Articles of Dissolution is 28 January 2011.

**THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
