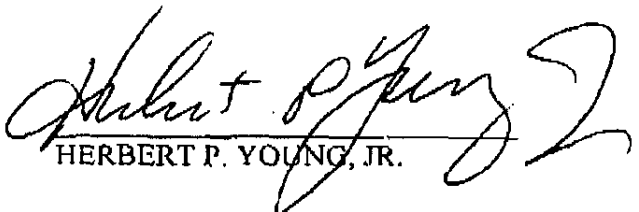
ARTICLE VI
