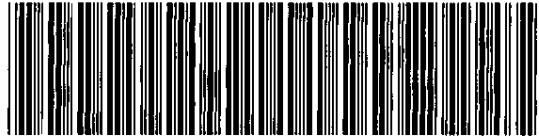

The undersigned, acting as an Organizer of a limited liability company under Florida Limited Liability Company Act, Florida Statutes, Chapter 608, adopts the following Articles of Organization:

1. Name: The name of this limited liability company, shall be "Southern Style Fashions, L.L.C."

2. Address: The mailing address and the street address of the principal office of this limited liability company is 2854 SW 3<sup>rd</sup> Terrace, Okeechobee, FL 34974-5965.

3. Initial Registered Agent and Registered Office: The name of this limited liability company's initial registered agent, whose Consent to Appointment as Registered Agent is included with these articles, is: Colin M. Cameron, Esq., P.A., and the street address of the initial principal office of this limited liability company is: 200 N.E. Fourth Avenue, Okeechobee, FL 34972-2981.

4. Duration: The period of duration of this company shall be perpetual, *provided, however*, that the death, insanity, bankruptcy, retirement, resignation, or expulsion of any member shall cause a dissolution of the organization.

5. Purpose: This limited liability company is organized and authorized to conduct any lawful business, enterprise or purpose not prohibited under Florida Statutes, Chapter 608.

6. Powers: This limited liability company shall have all powers provided by Florida Statutes, Section 608.404, or any successor statute thereto, and all powers not otherwise prohibited by law.

7. Management: The business of this limited liability company shall be conducted under the management of its members, all of whom shall participate in management authority for this limited liability company in all matters.

company must make a capital contribution to this limited liability company in an amount determined by the then existing members of this limited liability company.

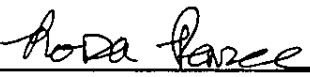
