ARTICLES OF ORGANIZATION

of

CONSOLIDATED RIGGING HOLDINGS II, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

The name of the limited liability company shall be Consolidated Rigging Holdings II, LLC (the "*Company*"). The mailing and street address of the principal address of the Company in Florida shall be 4700 North Pearl Street, Jacksonville, Florida 32206.

ARTICLE II

PURPOSES AND POWERS

ARTICLE V**TERMINATION OF EXISTENCE**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of 2/3 of the members.

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The managers shall be elected in the manner set forth in the Operating Agreement of the Company.
