STATE OF FLORIDA ARTICLES OF ORGANIZATION

OF

CONCEPT STYLE ITALY, LLC

(A Florida Limited Liability Company)



The undersigned, for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is CONCEPT STYLE ITALY, LLC

ARTICLE II - ADDRESS

The mailing address and the principal place of business of the Company is: 150 S.E. 2nd Avenue, Suite #1010, Miami, Florida 33131.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are tiled with the Florida Department of State. The Company's existence shall be perpetual. unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to operate the business of CONCEPT STYLE ITALY, LLC, and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. ARTICLE V - ADMISSION OF NEW MEMBERS

<u>ARTICLE VI - CONTINUATION OF BUSINESS</u>

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members; otherwise, the Company shall be dissolved.

ARTICLE VII - MANAGEMENT
