**ARTICLES OF ORGANIZATION
OF
SLAMA SERVICES, LLC**

1. Name. The name of this limited liability company is Slama Services, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, subject only to the terms of the Operating Agreement.
4. Place of Business. The mailing and street address of the Company's principal office is 3375 Sandpiper Way, Naples, Florida 34109.
5. Registered Agent and Office. The name of the initial registered agent of the Company is Thomas B. Garlick, Esq. The street address of the initial registered agent of the Company is 9115 Corsea del Fontana Way, Suite 100, Naples, Florida 34109.
6. Management of the Company. The Company shall be a manager-managed Company, in accordance with the Operating Agreement adopted by the members. The name and address of the initial manager, who shall serve until the first annual meeting of the members or until its successors is elected and qualified, is Richard F. Slama, 3375 Sandpiper Way, Naples, Florida 34109.
7. Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.
8. Certificated Interests. The member's interests in the Company may be evidenced by certificates, at the discretion of the manager.
9. Additional Members. The company shall have the right to admit additional members pursuant to the terms and conditions of the Operating Agreement to be adopted by the members.
