

ARTICLES OF ORGANIZATION

OF

SOUTHERN SUN STABLES, L.L.C.

The undersigned persons, acting as the organizers of **SOUTHERN SUN STABLES, L.L.C.**, (The "Company") under the Florida Limited Liability Company Act, Chapter 608, <u>Florida Statutes</u>, adopt the following Articles of Organization:

ARTICLE I. NAME AND ADDRESS
