Any reference to a member of the Company using the term "managing member" or "member-manager" (or any similar term or title) shall be deemed a reference to such member in the capacity as a manager of the Company, provided that such member otherwise has been duly appointed, designated or elected and otherwise qualifies to serve as a manager.

#### Article VI - Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.

#### Article VII - Commencement of Existence

The Company's existence shall commence on and as of February 11, 2009, if these Articles of Organization are filed with and by the Florida Department of State within five (5) business days after such date, and otherwise on and as of the date of such filing.
