1. The name of the Company is LEE HUBLER TRUCKING LLC, and its Document Number is L09000015766. The Articles of Amendment filed herewith result in a change in the name of the Company to MIC TRUCKING LLC.
2. The original Articles of Organization of the Company were filed on February 16, 2009, and were effective as of February 11, 2009. These Articles of Amendment have been duly authorized, approved, executed and delivered for filing in accordance with Section 608.411, Florida Statutes.
3. These Articles of Amendment, and the Amended and Restated Articles of Organization attached hereto, were duly approved and adopted by unanimous action of the Members of the Company on May 25, 2009.
4. The Articles of Organization of the Company are hereby amended by replacing same in their entirety with the Amended and Restated Articles of Organization beginning on the immediately following page.
5. These Articles of Amendment, and the Amended and Restated Articles of Organization attached hereto, shall become effective upon filing by the Department of State of the State of Florida.

The undersigned authorized representative hereby executes these Amended and Restated Articles of Organization ("Articles") for the purpose of organizing a limited liability company in accordance with the laws of the State of Florida.

Article I – Name

The name of this limited liability company (the "Company") shall be:

MIC TRUCKING LLC

Article II – Principal Office and Mailing Address

The initial mailing address and initial street address of the principal office of the Company are:

3445 Butler Street
Pittsburg, PA 15201

Article III – Registered Office and Registered Agent

The address of the initial registered office of the Company, and the initial registered agent of the Company at such office, are as reflected in the records of the Florida Department of State. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

Article IV – Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. The Operating Agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.

Article V – Management of Business

Except for rights that are specifically reserved to the members in the Operating Agreement of these Articles, management of the Company shall be vested in its manager(s). Accordingly, the Company shall be a manager-managed company. Any reference to a member of the Company using the term “managing member” or “member-manager” (or any similar term or title) shall be deemed a reference to such member in the capacity as a manager of the Company, provided that such member otherwise has been duly appointed, designated or elected and otherwise qualifies to serve as a manager.

Article VI – Amendment of Articles of Organization

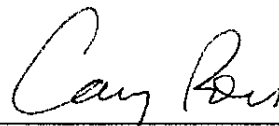
The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.

Article VII – Commencement and Continuance of Existence

The Company’s existence shall commence on such date as determined by the Florida Department of State. Thereafter the Company’s existence shall continue perpetually unless and until the Company is dissolved in accordance with law.
