ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
JDBL INVESTMENTS, LLC

The undersigned being the Manager and Authorized Representative of JDBL INVESTMENTS, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is JDBL Investments, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective February 16, 2009.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I.
NAME

"The name of the Limited Liability Company shall be JDBL Investments, LLC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
5. These Articles of Amendment have been approved by unanimous Written Action of the Sole Member and Manager dated March 4, 2009, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

The execution of these Articles of Amendment of the Articles of Organization by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true and correct.
