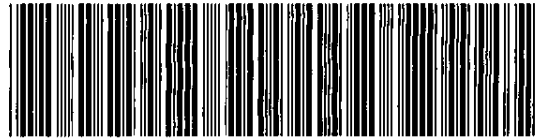



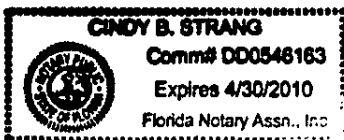
ADMISSION OF NEW MEMBERS:
