

A LIMITED LIABILITY COMPANY**

THE UNDERSIGNED, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - NAME

The name of the Limited Liability Company (hereinafter referred to as "Company") is **EMERALD COAST INSURANCE SERVICES OF PANAMA CITY, L.L.C.**

ARTICLE II - PRINCIPAL OFFICE

The mailing address and street address of the principal office of the Limited Liability Company is 2003 East Avenue, Panama City, Florida, 32405.

1. Upon written agreement of two-thirds of the membership.
2. Upon the death, retirement, resignation, expulsion or bankruptcy of a Member or any other event which terminates the continued membership of a Member in the Company, unless the remaining Members, within ninety (90) days after the event of occurrence, unanimously elect to continue the business of the Company pursuant to the terms of these regulations.

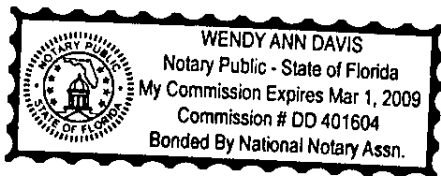

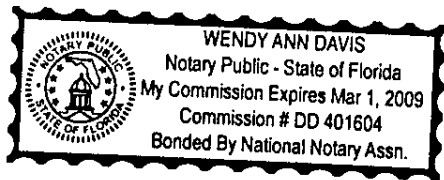
