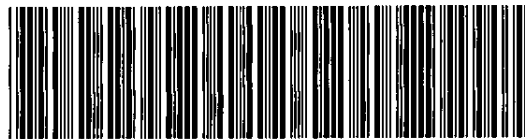

**(Name and Principal Place of Business)**

(Right to Continue Business)


