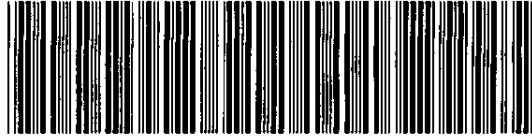



**ARTICLES OF ORGANIZATION
OF
H2O LIFE TECHNOLOGIES, LLC**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is H2O LIFE TECHNOLOGIES, LLC (the "Company").

ARTICLE II

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE VII

ADDITIONAL MEMBERS


Additional Members may be admitted upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company.
