**ARTICLES OF ORGANIZATION  
OF  
VENTURE MACHINE PRODUCTIONS, LLC**

1. Name. The name of this limited liability company is **VENTURE MACHINE PRODUCTIONS, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company shall be effective on **February 20, 2009** and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is **1352 TURTLE DUNES COURT, PONTE VEDRA BEACH, FLORIDA 32082.**

5. Registered Agent and Office. The name of the initial registered agent of the Company is Joseph Rugg. The street address of the initial registered agent of the Company is 401 East Jackson Street, Suite 1700, Tampa, Florida 33602.

6. Contributions to the Company. No cash or property (other than cash) has been contributed to the Company by its members. No additional contributions have been agreed upon.

7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company shall be managed in accordance with the operating agreement adopted by all of the members. Until and unless changed by the operating agreement, William Eng shall act as the manager/managing member of the Company, and he shall be empowered to designate other persons as officers of the Company. William Eng and the Company's officers shall have full power and authority to act for and on behalf of the Company, including, without limitation, to enter into contracts, open and close bank accounts, incur and pay debts and expenses, file papers with the Internal Revenue Service, and engage professionals and other advisors, and all persons may rely on these Articles of Organization to deal directly with each named individual on all matters relating to the Company.
